

PUBLIC NOTICE OF HEARING

TO THE CITIZENS OF THE STATE OF MISSISSIPPI:

NOTICE IS HEREBY GIVEN, in accordance with *Miss. Code Ann.* §§ 77-3-47 and 77-3-21 and RP 15 of the Commission's *Public Utilities Rules of Practice and Procedure*, that the Mississippi Public Service Commission (Commission) has scheduled a hearing on Tuesday, January 7, 2025, beginning at 10:00 a.m., or as soon thereafter as may be practicable, in Docket No. 2024-AD-37. At said date and time, the City of Holly Springs is summoned to appear and show cause as to why the Commission should not find the City of Holly Springs in violation of *Miss. Code Ann.* § 77-1-33 for obstructing the investigation of the Commission into the adequacy of service being provided by Holly Springs Utility Department, a matter squarely within the jurisdiction of the Commission pursuant to *Miss. Code Ann.* § 77-3-21. Immediately thereafter, the Commission shall conduct a Section 77-3-21 hearing in order to make such findings as may be supported by proof as to whether the City of Holly Springs is rendering reasonably adequate electric service.

The scheduled hearing of these matters shall be held before the Full Commission in the Commission Hearing Room located on the first floor of the Woolfolk State Office Building, 501 N. West St., Jackson, Mississippi 39201. At said hearing, the City of Holly Springs shall be afforded the opportunity to be heard upon those allegations brought by the Commission in its Complaint filed in the subject docket. All persons testifying will be subject to cross-examination by the Commission and the independent consultants hired to investigate the adequacy of the electric service being provided by the Holly Springs Utility Department.

Further notice will not be provided to the public if this hearing is cancelled for any reason.
